





#### I. Companies Fresh Start Scheme, 2020:

The Ministry of Corporate Affairs vide its circular dated 30<sup>th</sup> March 2020 has provided an opportunity to the defaulting companies to file their belated documents within 6 months (1<sup>st</sup> April 2020 to 30<sup>th</sup> September 2020) with the MCA-21 registry by way of introduction of the Scheme called as "Companies Fresh Start Scheme, 2020" with normal filing fees.

#### **Applicability:**

- The scheme is applicable for any company, including foreign company, which are incorporated under Companies Act 2013 or any other previous Company Law and had defaulted in filing of any forms and returns with the MCA-21.
- Specified list of 76 forms can be filed under the scheme and Form SH-7 & Charge related documents (CHG-1, CHG-4, CHG-8 and CHG-9) are specifically excluded. The list of 76 forms are attached for your reference,
- Provides an opportunity for withdrawal of appeal where notice is not issued or complaint filed or an order passed by a court or by an adjudicating authority under the Companies Act, 2013 for violation of provisions under the Act;
- Extension of timeline for filing appeals u/s 454(6) of the Act where default in filing documents has been made and penalties initiated by Adjudicating Authority under the Act and appeal is not yet filed by the company.
  - Additional period of 120 days shall be allowed from the last for filing the appeal which falls between 1<sup>st</sup> March 2020 to 31<sup>st</sup> May 2020.
  - ii. No prosecution shall be initiated for non-compliance during such period of 120 days
- Opportunity to declare the inactive companies as dormant under Section 455 of the Act;

Upon submission of the belated documents the company shall make an application for issue of immunity certificate pursuant to the Scheme vide Form CFSS-2020 for which there is no filing fee.

The immunity obtained under the Scheme is not applicable in matter of any appeal pending before any court of law and in case of management disputes of the company pending before any court of law.







## II. LLP Settlement Scheme, 2020:

The Ministry of Corporate Affairs ('MCA') as a move to promote ease of doing business in India had launched amnesty scheme known as "LLP Settlement Scheme, 2020". The scheme has been launched considering the fact that large number of LLP's (especially Start-ups) are not complying in filing their statutory documents with the Registrar with nominal fee of  $\stackrel{?}{\sim}$  10/- per day for each day during which the default continues subject to a maximum of  $\stackrel{?}{\sim}$  5,000/- per Form.

Further, due to non-filing of the required documents on time the LLP's and their designated partners are liable for criminal prosecution along with penalties.

### **Applicability:**

Any defaulting LLP is permitted to file following belated documents, which were due for filing as on 31<sup>st</sup> October 2019 within 6 months (1<sup>st</sup> April 2020 to 30<sup>th</sup> September 2020).

- Form-3 (Information with regard to LLP agreement and changes, if any, made therein);
- Form-4 (Notice of appointment, cessation, change in name/ address/ designation of a designated partner or partner and consent to become a partner/ designated partner);
- Form-8 (Statement of Account & Solvency (Annual or Interim));
- **Form-11** (Annual Return of LLP).

#### It also provides immunity from Prosecution if all the pending Forms are under the scheme.

This Scheme shall not apply to LLP's which has made an application in **Form-24** to the Registrar, for striking off its name from the register as per provisions of Rule 37(1) of the LLP Rules, 2009.

# III. Relaxation of various regulations pursuant to the circulars issued by the SEBI:

In view of the evil spread of COVID-19, the Capital Market Regulators- SEBI, Stock Exchanges-NSE, BSE have also come forward and are continuously taking steps for enduring development of Capital Market and simplifying compliance requirements in the interest of stakeholders, during such catastrophe. SEBI has so far issued belowmentioned circulars granting relaxations with Compliance requirements:

- Circular dated March 19, 2020
- Circular dated March 23, 2020
- Circular dated March 26, 2020
- Circular dated March 27, 2020

Further, NSE & BSE on comprehending the challenges being faced by company's personnel working from home and requirement to submit necessary compliance within appropriate deadlines, have allowed submission of documents without signatures i.e. SD/- mode is allowed through their online Listing Portals. *The list of reliefs are attached for your reference.*






