

## SEIS update & Way-forward:





- The eligible services for FY 2019-20 are notified in Annexure 3X with rate of incentive being rationalized with eligible incentive being capped at INR 5 Crores per IEC for FY.
- Applications for claim of incentive for FY 2018-19 & FY 2019-20 can be filed before 31 December 2021 (with a late cut of 5% for FY 2018-19). Any application filed after the cut of date of 31 December 2021 is considered to be time barred.
- Application for claim of incentive against services for which consideration is received in INR (notified in Annexure 3E) is not allowed for claim of incentive for EV 2019-20
