# ADVANTAGES AND DISADVANTAGES



Service providers of notified services, located in India, shall be rewarded under SEIS, subject to conditions as may be notified



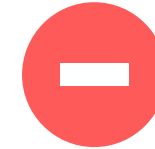
Such service provider should have minimum Net Free Foreign Exchange earnings of US\$15,000 in preceding financial year to be eligible for the scrip



In order to claim reward under the scheme, Service provider shall have to have an active IEC at the time of rendering such services for which rewards are claimed.



Net Foreign Exchange = Gross Earnings of Foreign Exchange minus Total expenses / payment / remittances of Foreign Exchange by the IEC holder, relating to service sector in the Financial year



Supply of a service from India through commercial presence in any other country.



Supply of a 'service' from India through the presence of natural persons in any other country.



SEIS scheme is not available for units operating as STPs



Service Providers not holding IEC in the year of export are not eligible for claim of incentives



Duty Credit Scrips (scrips) shall be granted as rewards under SEIS scheme

- The scrips can be utilized for making duty free procurements (imports and domestically procured) and there is no actual user condition for transfer of the assets procured
- The Duty Credit Scrips can be used for:
  - Payment of Customs Duty on imports of eligible inputs or goods;
  - For payment of customs duty and fee in case of export obligation defaults. However, penalty/ interest needs to be paid in cash
- The scrips are freely transferable and can also be sold in the open market (at a discounted rate)

### Evaluation

The services provided by the entity are to be evaluated in the context of eligibility for claim of incentive

### Pre-

requisites  
Obtaining RCMC from relevant export council

### Application

#### Filing

Filing an application in ANF 1 with the DGFT authorities along with a CA certificate

Utilization/ sale of scrips

The scrips obtained are to be registered at customs and DGFT enabling transfer/ utilization.

Liaising for obtaining scrips

Jurisdictional authorities to be explained on the eligibility for claim of incentive

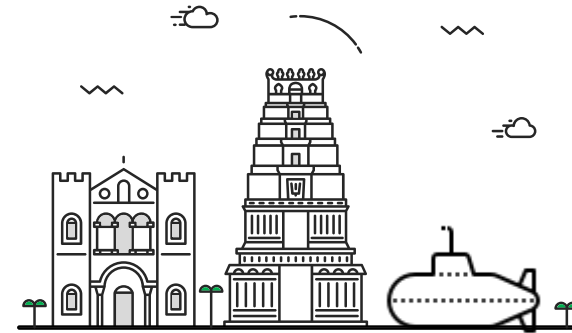
